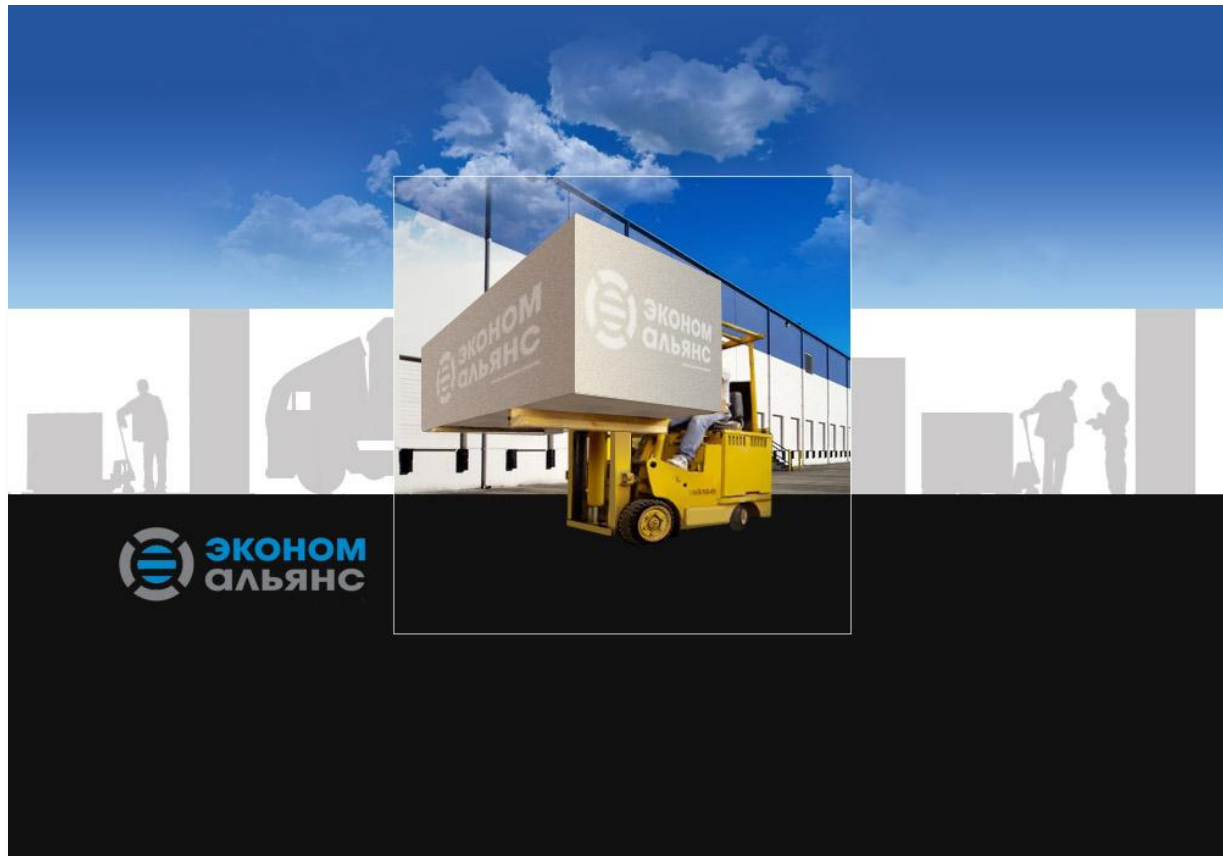

- We offer insurance, preparation of cover documents, informational support, and other services.

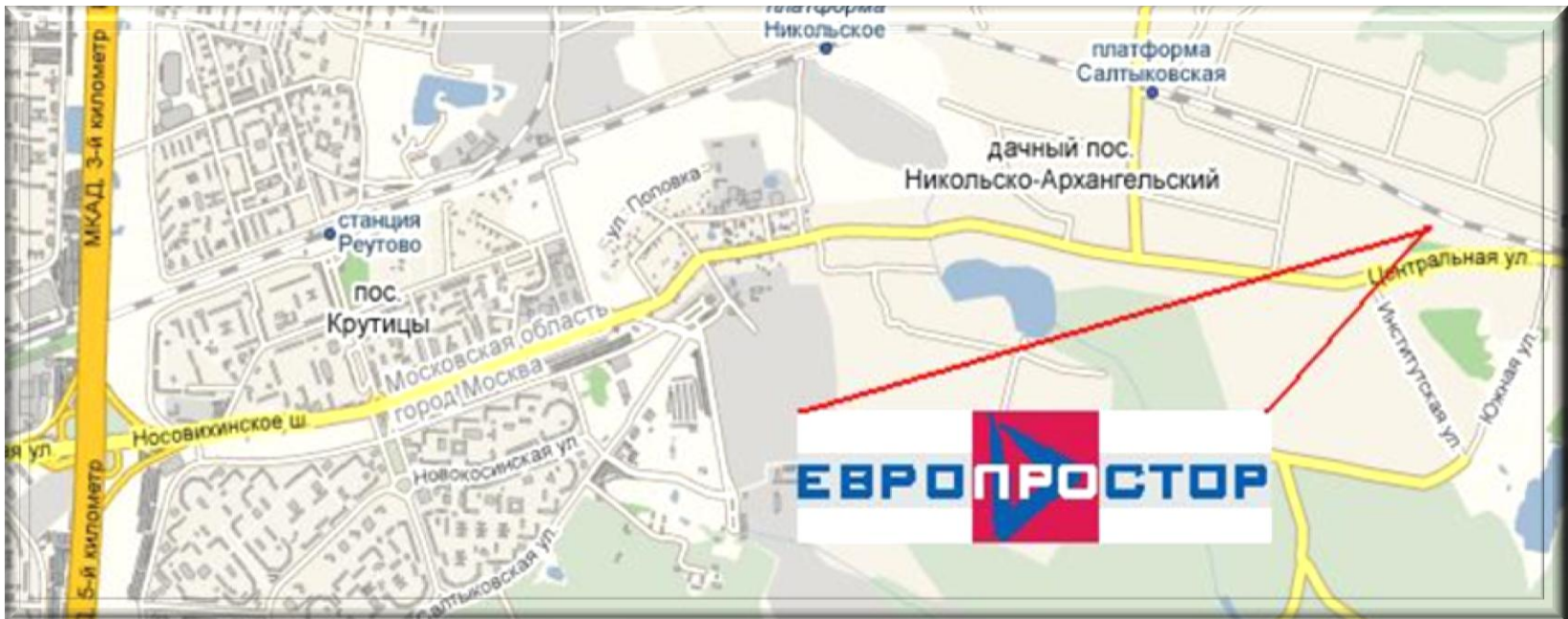

Company location

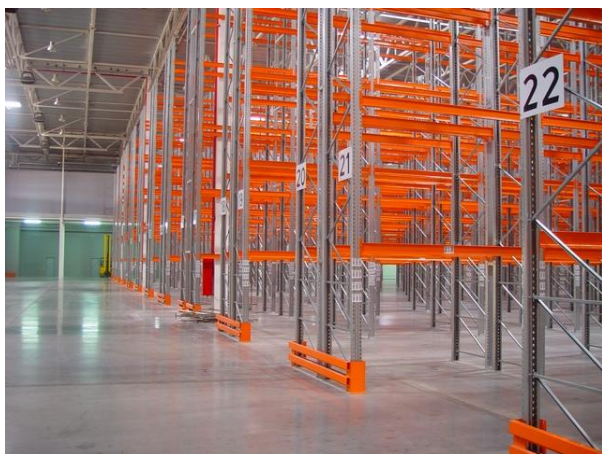
Warehouse complex

JSC "EconomAlliance" is located 6 km away from MKAD (Moscow Ring Highway) by Nosovihinskoe shosse. (the East)

Address: Moscow region, Balashiha district, the city block of Saltykovka.



Description of the warehouse complex



Class "A" warehouse complex:

- The area of the ground floor is 10 080 m² with pallet capacity of 14 500 pallet places;
- Column space is 12 x 24 m;
- Operating height of the shelves is 12.55 m, 6-level flow-rack system;
- Mezzanine is 900 m², 3 840 of storage cells;
- The warehouse is equipped with 11 gates with coverage and flattening bridges;
- Level and dustless concrete floor;
- Modern offices - 500 m²;
- Fiber-optic telecommunications - telephone and Internet;
- 24-hour guarded parking lot for cargo (11 places) and private vehicles (18 places).

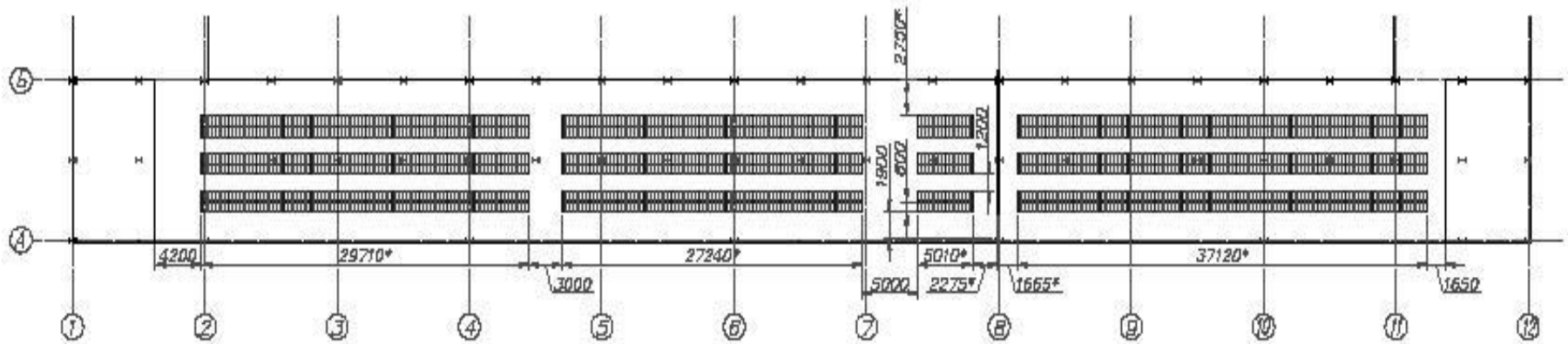
Mezzanine

MEZZANINE is very convenient and is used for small items and piece goods.



For our clients we offer mezzanine on the basis of flow-rack stands and specialized mezzanine elements, which generally allows us to create individual configurations depending on client's specific requirements.

- Flow-racks storage zone (MEZZANINE) occupies 900 m² of the warehouse complex.
- The height of the first floor of the mezzanine is 6.4 m.
- There are 3 840 storage cells within the two floors of mezzanine. Each cell is 80 cm (height) x 60 cm (width) x 80 cm (depth).
- Load capacity of the floor is up to 1,200 kg per m², load capacity of a shelf is from 200 to 1,000 kg per shelf.



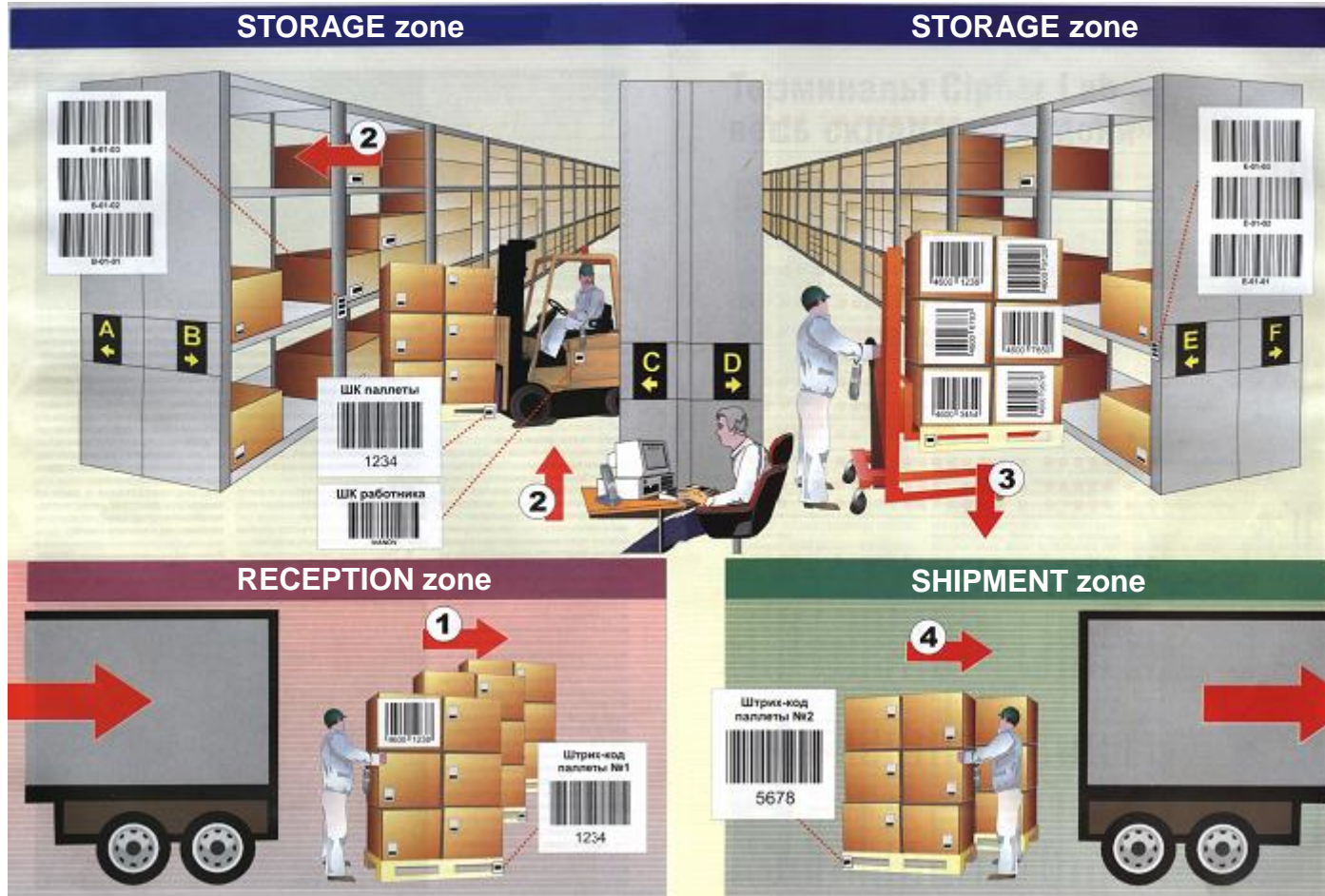
- ▶ the passage width between the aisles. From the second floor the packaged sets of goods are placed on pallets and delivered to the shipping zone. Every cell has its unique address in the warehouse data system.
- ▶ The mezzanine is equipped with systems for cooling, ventilation and conditioning, which help to maintain the required temperature mode.

Microsoft Axapta stock bookkeeping program

The management of the warehouse is carried out via specialized logistics solution of "Columbus IT", the international IT integrator. Advantages of the system are as follows:

- Automation of all business processes of the warehouse;
- Automatic submission to FIFO and LIFO principles for all or specific types of goods;
- Optimization of slotting of goods nomenclature for warehouses with complex structure;
- Control of goods circulation within the warehouse in real time;
- Control of expiry date of goods;
- Generation of detailed reports to clients on the circulation of goods;
- Considerable opportunities for integration with client's software;
- On-line access to the system:
 - ✓ *Submission of requests for reception/shipment via WEB-interface*
 - ✓ *Control of order status*
 - ✓ *Control of balance depot stock*
 - ✓ *Flexible system of automatic notifications (upon reception/shipment, change of goods status, order readiness for shipment, and so on)*

Process automation

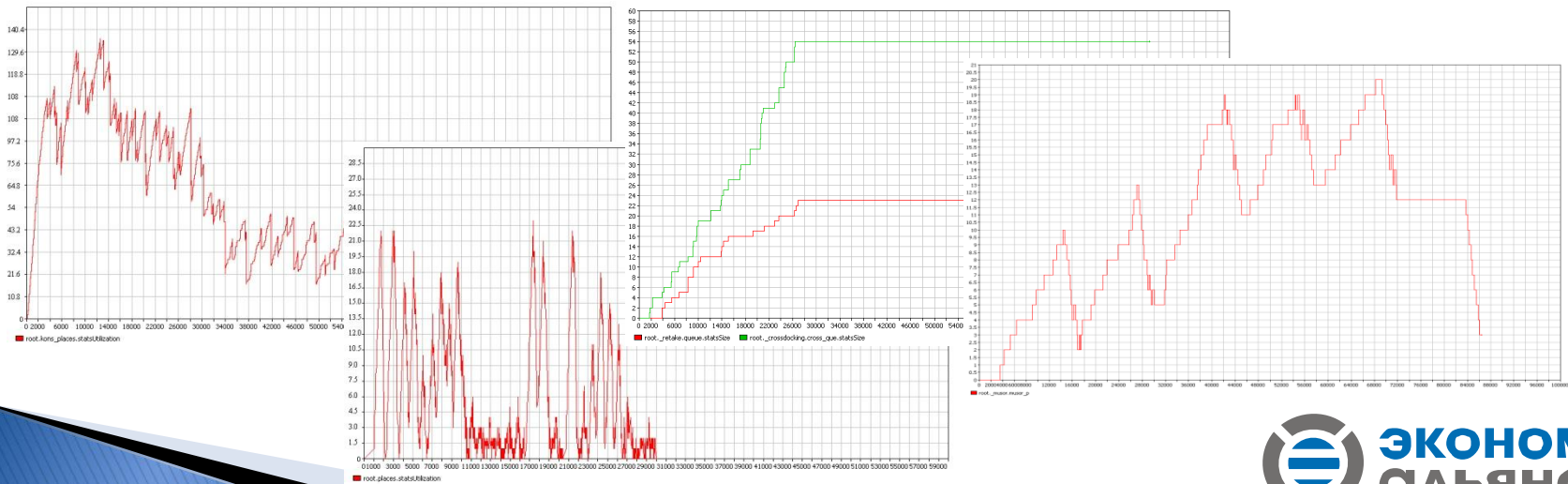
